

Alpine Research llc Limited 1 Year Warranty

WiFire Remote a product from ALPINE RESEARCH LLC. Alpine Research llc extends a one (1) Year warranty to the original owner of this system. This warranty is extended to the original purchaser of the product and is non-transferable to other persons. Should any part fail because of defective workmanship or material one year from the original date of purchase, Alpine Research llc will repair or, at Alpine Research llc's discretion, replace the defective parts.

Replacement parts will be available at no charge to the original purchaser for the first (1) one year of this warranty, and will be available at market cost thereafter. Alpine Research llc reserves the right to replace a defective product with the same or updated version, at Alpine Research llc's discretion.

PRODUCTS COVERED BY THIS WARRANTY

As indicated above, the benefits provided to the consumer by this Alpine Research llc warranty do not exclude any other rights and remedies of the consumer under any law in relation to the goods and services to which the warranty relates. This warranty applies to any Alpine Research llc products you have purchased from Alpine Research or an authorized Alpine Research llc reseller.

Our policy is to offer product warranties and to perform services only on products purchased from an authorized Alpine Research llc reseller and only accompanied by a receipt or proof of purchase. If you purchase an Alpine Research llc product from an unauthorized reseller or if the original factory serial number has been removed, defaced or altered, this Alpine Research llc warranty will not be valid.

WARRANTY COVERS

Alpine Research llc warrants its products contained in their original packaging against defects in material and workmanship when the products are used normally for their intended purposes, for 1 year. Overheating of the Wifire Remote due to placement in an area hotter than 135° will void all warranties. All of Alpine Research llc's limited warranties begin on the date of purchase. **PLEASE RETAIN A COPY OF YOUR RECEIPT AS PROOF OF PURCHASE.** The length of this Alpine Research llc Limited Warranty (as opposed to statutory guarantees or non-excludable statutory warranties), and including any implied warranties, will be one (1) year from the time of purchase.

The "original purchaser", for the purposes of this warranty, is the original 'Primary User' registered at www.wifireremote.com (the website). Original purchase must have been purchased from Alpine Research llc (www.wifireremote.com website) or an Alpine Research llc authorized reseller.

There are some components of current Wifire Remote products, such as, batteries, and power supplies that will have warranty lengths that differ from the underlying Wifire Remote product.

TO THE EXTENT PERMISSIBLE BY APPLICABLE LAW, THIS WARRANTY AND ANY IMPLIED WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

WHAT IS NOT COVERED BY THE WIFIRE REMOTE WARRANTY

This warranty does not apply if the Wifire Remote product fails due to damage from shipment out of Alpine Research llc control, handling, storage, accident, abuse or misuse, or if it has been used or maintained in a manner not conforming to product manual instructions, has been modified in any way, or has had any serial number removed or defaced. **This warranty does not cover claims, which do not involve defective workmanship or materials provided by Alpine Research LLC.**

YOUR RESPONSIBILITIES

In order to obtain warranty service under this Alpine Research llc Limited Warranty, during the Alpine Research llc product's warranted period, as set forth above, you must submit a valid claim to Alpine Research llc and:

1. **obtain an Return Merchandise Authorization (RMA) number by contacting Alpine Research llc technical support, contact information found at www.wifireremote.com;**
2. Return (at your expense) the failed product to the address provided by Alpine Research llc technical support; and
3. Provide Alpine Research llc with proof of the original date of purchase.

Alpine Research llc will not accept collect shipments for warranty service, but replacement products will be returned to you at Alpine Research llc's expense, after completing the above three steps. Goods presented for repair may be replaced by refurbished goods of the same type rather than being repaired. Refurbished or used parts may be used to repair the goods. If Alpine Research llc, by its sole determination, is unable to replace the defective product, it will refund the depreciated purchase price of the product.

ALPINE RESEARCH LLC'S RESPONSIBILITIES

As long as you fulfill your obligations under "**YOUR RESPONSIBILITIES**" above, Alpine Research llc will replace your product with the same or functionally equivalent product, at its discretion, free of charge (except for shipping charges as provided above).
